## Administrative Operations

- Department Inspections: We are moving forward with the Department Inspection initiative for the 2023-2024 term and have plans to complete ten (10) inspections this year. The hope is that we will have the first inspection scheduled for the beginning of October and have all inspections completed by May 2024, prior to the start of Department conventions. In the coming weeks we will be reaching out to the Departments that have been selected by the Commander-in-Chief as well as the inspection team members to begin working through availability and scheduling. Additionally, the inspection team will be conducting initial and refresher training in September before we start our schedule.

- There are currently 48 Posts under suspension, three of which are new. No Post consolidations were processed this week pursuant to Section 209 of the National Bylaws. The organization has 5,666 chartered Posts.
- Administrative Operations is engaged in 12 Article IX Disciplinary Actions, 10 Administrative Actions and 10 membership eligibility challenges.
- We have 54 Bylaws/Articles of Incorporation submissions in for review, eight of which are new; current turnaround time on Bylaws/Articles of Incorporation submissions is approximately 30 days.

### **National Legislative Service**

- **VFW-Supported Amendment Passes Senate:** The Senate passed an amendment to the *Military Construction, Veteran Affairs, and Related Agencies Appropriations Act, 2024*. In July, the VFW testified in favor of H.R. 705, *Veterans 2nd Amendment Protection Act*, which mirrors the aforementioned bill. This amendment would block VA from automatically referring veterans with fiduciaries to the National Instant Criminal Background Check System (NICS), which prohibits the ownership of firearms. It would also require that any VA referrals to NICS must first have the order of a judge indicating that the person is a danger to themselves or others. The VFW sees this as a necessary step to ensure the right of due process for veterans. [Read more](#).
- **Senate Committee Hearing on VA Accountability:** The Senate Committee on Veterans' Affairs held an oversight hearing on VA accountability and transparency. Efforts to streamline VA's ability to hire and fire employees in an efficient manner were discussed. "Accountability and transparency must be cornerstones of fulfilling VA's mission to provide high quality care and benefits to our veterans. We can all agree that bad actors at VA cannot and will not be tolerated," said Chairman Jon Tester. [Watch the hearing](#), which begins at the 12:18 mark.
- **Expected COLA Increases Announced:** The Social Security Administration (SSA) announced a 3.2% benefit increase for 2024. VA compensation payment rates will match the rates from SSA. Veterans can expect to see the new amounts starting with their January 2024 payment. [Read more](#).
