## **Administrative Operations**

- Department Inspections: We are moving forward with the Department Inspection initiative for the 2023-2024 term and have plans to complete ten (10) inspections this year. The hope is that we will have the first inspection scheduled for the beginning of October and have all inspections completed by May 2024, prior to the start of Department conventions. In the coming weeks we will be reaching out to the Departments that have been selected by the Commander-in-Chief as well as the inspection team members to begin working through availability and scheduling. Additionally, the inspection team will be conducting initial and refresher training in September before we start our schedule.

- There are currently 50 Posts under suspension, four of which are new. We have processed one Post consolidation pursuant to Section 209 of the National Bylaws. The organization has 5,664 chartered Posts.
- Administrative Operations is engaged in 10 Article IX Disciplinary Actions, 12 Administrative Actions and 10 membership eligibility challenges.
- We have 49 Bylaws/Articles of Incorporation submissions in for review, five of which are new; current turnaround time on Bylaws/Articles of Incorporation submissions is approximately 30 days.

### **Meetings and Events**

- Nov. 5-7, 2023 – Initial site visit to Columbus, Ohio, for 2025 National Convention (Aug. 9-14, 2025). The purpose was to review and confirm hotels and convention center to get contracts started. Target date to finalize is Jan. 31, 2024.

- Nov. 15-17, 2023 – Preplanning site visit to Louisville for 2024 National Convention. ### **National Legislative Service**

- House Subcommittee Hearing on Pending Legislation: VFW National Legislative Deputy Director Kristina Keenan testified before the House Veterans' Affairs Subcommittee on Economic Opportunity regarding pending legislation related to education and other benefits. She conveyed the VFW's support to expand the monthly housing allowance to student veterans taking online courses during summer semesters. She also spoke about a bill to remove the red tape that has caused some schools to drop out of the GI Bill program. "This would modify the requirement for schools to provide personalized information about costs and financial assistance. The new language would give schools more flexibility by lessening the barrier to receiving VA education funding," Keenan said. She also stated the VFW's support for a bill to reimburse the VA Home Loan funding fee to service members who apply for VA disability but receive a rating decision after finalizing the purchase of a home. - Annual Military Suicide Report Released: The Department of Defense (DOD) released its *Annual Report on Suicide in the Military Calendar Year 2022*. In total, 492 service members across components lost their lives to suicide in 2022, which is a decrease from 2021. In addition, a total of 168 family members died by suicide in 2021, which is the most recent year data available. Among service members, suicide rates (deaths per 100,000) for active duty, Reserve, and National Guard components were 25.1, 19.1, and 22.2, respectively. While the rates among Reserve and National Guard personnel continue to show neither upward nor downward trends, the rate of active-duty members dying by suicide has continued to trend upward from 2011-2022. The 2021 suicide rates among family members appeared to be lower than in 2019 and 2020, though no time-based trends have been established. Importantly, the report outlines DOD's ongoing and planned actions to curb suicide numbers including implementing recommendations from the Suicide Prevention and Response Independent Review Committee (SPRIRC).
